## USRC COMPLETES HISTORIC PRESERVATION PLAN FOR WASHINGTON UNION STATION

**Washington, DC** – Union Station Redevelopment Corporation (USRC) in partnership with Amtrak, Akridge, and Union Station Investco (USI) announce the completion of the first ever Historic Preservation Plan for the Washington Union Station complex.

This plan marks the culmination of a 14-month drafting process where station partners worked with Building Conservation Associates, Inc. (BCA) to ensure the plan included a catalog of historical information from the Station's construction to present day, as well as a technical analysis of the current condition of the historic elements, and will serve as a guide for future preservation, rehabilitation, restoration, and reconstruction efforts. The historic preservation community was involved throughout the lengthily drafting process, and met regularly with the planning team. Key stakeholder groups that participated include: Capitol Hill Restoration Society; Committee of 100 on the Federal City; DC Preservation League; DC State Historic Preservation office; National Trust for Historic Preservation; and US Commission of Fine Arts.

Upon its release, the Union Station Preservation Coalition notified USRC of its official endorsement of the Historic Preservation Plan as an essential planning tool for the purposed expansion of Union Station and construction of Burnham Place.
