9/2/2026	2.1	Page 16 6.1.5.6 6.2.2 Page 19 7.3	Section 6.2.2 (solicitation page 16) identifies "Selection Questions" as a required component of the Statement of Qualifications and references Section 6.6. In addition, Section 6.1.5.6 (solicitation page 16) provides formatting requirements for responses to questions contained in Section 6.6. However, the RFQ proceeds directly from Section 6.5 to Section 7 (solicitation pages 17-18) and no Section 6.6 appears in the solicitation. Additionally, Section 7.3 (solicitation page 19) is titled "Phase 2: Technical Evaluation - Selection Questions and Information Disclosure," which suggests that Selection Questions are part of the Phase 2 RFP process rather than the Phase I SOQ submission. Please clarify whether: 1. Section 6.6 containing Selection Questions was inadvertently omitted from the RFQ and is required as part of the Phase I SOQ submission; or 2. The references to Section 6.6 in Sections 6.1.5.6 and 6.2.2 are in error, and Selection Questions will instead be issued and evaluated as part of the Phase 2 RFP process.
